







Maternal Penning to Enhance Survival of Caribou within the Klinse-Za Herd

External: Issued June 09, 2017

This external memo is forwarded to report on events and conditions occurring since the caribou cow capture that took place on March 22 and 23, 2017.

Days in pen \rightarrow 78

Summary of significant events since capture

- Total calf count for this year is as follows: 9 cows pregnant to start, 1 abortion, 1 stillborn, leaving us with 7 calves to date.
- We have been keeping a close eye on the last calf that was born. She didn't seem to be as healthy as the rest and was not using one of her hind legs. However, she is now 17 days old, looks better, is using her leg and so we think she is probably out of trouble.
- The snow is completely gone from in and around the pen, and therefore full operation of the electrical fence is a priority.



- There have been no compromises to the pen. However a grizzly was found within approx. 20m of the pen (see photo of print above). The grizzly left the area when an unknowing work crew arrived on the scene, probably scaring the bear off; it has not returned since.
- In the past week, several other bears have been seen in the vicinity of the pen and one had to be dispatched by the shepherds. Around the same time, tracks and a broken electric wire at the pen was evidence that a bear had likely tried entering the pen area.
- According to relocations of radio-collared wolves, there is some evidence that wolves may have established a den site about 8km from the pen so shepherds are currently investigating that.
- First phase (pre-calving) of the pellet collection is now completed for both wild and penned caribou. The next phase (post-calving) will be happening soon. This study will be used to contrast health/stress levels of penned vs. wild caribou, among many other comparisons.

- On May 10th, we hosted the FWCP (Peace Region) board members to a visit at the mat pen site.
- May 29th the Nîkanêse Wah tzee Stewardship Society held a general meeting. During this meeting we discussed, among other things, selection of a new site for the mat pen in 2018.
- The 2016 final year-end report is now complete and has been uploaded to the FWCP website.
- On June 06th, we hosted the BC Governments' new management team that is going to provide a specific focus on caribou recovery in BC.
- There were a couple of mistakes in the cumulative data results from the pen sent in the last newsletter so we have fixed those errors and present the corrected version of the table below.
